2) Traffic Safety Program Updates (Pence)

- a) Update on COVID-19 Impacts on TxDOT's Traffic Safety Program
 - i) COVID is having significant impacts on Traffic Safety Program. TxDOT has suspended outreach efforts, child safety seat checks, meetings, etc. We have all learned a lot on how best to transfer meetings to virtual. The annual Traffic Safety Conference which will be virtual this year. Registration and info on the Conference can be found here: https://groups.tti.tamu.edu/cts/2020-traffic-safety-conference/

Mid year grant meetings will be virtual this year. Outreach is currently suspended thru May. This will be reevaluated later in the month.

b) Changes to HSP submission deadline

- i) There have been no changes due to COVID. Everything is on schedule including presenting to the Transportation Commission at the end of May. CARES Act extended the deadline for HSP to Aug. 1. Texas is on schedule for getting that submitted on-time. TxDOT will find out if HSP is approved in Sept. and will then begin executing those grants later in Sept.
- ii) Due to cancelled events and outreach there will be more carry over funds than normal. TxDOT is asking subgrantees to review budgets and if subgrantee will have more than \$5,000 in direct funds left over to do an amendment by June 30 so those funds are available Oct. 1. Otherwise those funds are not available until Jan. 1. This will help TxDOT cover projects next year if there are any funding delays in FY21.

- a) IADLEST DDACTS Project Update
 - i) Dan Howard Retired law enforcement officer. Has worked in 26 states to educate law enforcement on DDACTS. This includes 75 LEAs in Texas alone. The presentation notes are attached to the meeting notes.

 - i) Introduced staff of Jerard, Jordan, and Brennen
 - ii) Presented dashboard LEAs can use to analyze their data and compare to other LEAs, change in LEA DWI enforcement after implementing LEADRS,





Does implementing LEADRS within an LE agency increase DWI enforcement?






Does drugged driving behavior differ from alcohol impaired drivers?

Reason for stop/driving behavior from drug related DWI arrest:


When broken out by all 7 drug categories, the driving behaviors remain consistent. This indicates that the driving behaviors do not change based off the suspected impairment by the officer.






Reason for stop/driving behavior reporting from Alcohol related DWI arrest:

More DWI arrest are made off of reactive stops vs self initiated stops



Over 30% of all LEADRS cases obtained blood search warrants using the electronic blood search warrant feature.
